#### **CUSTOMS HINTS**

W.E.F. 1<sup>st</sup> April 1994, the Singapore Government has implemented a 3% Goods and Services Tax (GST) on the declared value of ALL import shipments. However, shipments of used personal effects/household goods are exempted from paying GST provided the owner can produce the following documents to use (fax or mail) before shipment arrives for our application to Customs for an exemption on his/her behalf.

#### For Foreigners Working in Singapore

- Declaration of Facts
- Passport copies showing personal particular
- → If Employment Pass / Work Permit has been approved
- Employment Pass / Work Permit (front & back copies of the card)
- Copy of the passport page showing Immigration Department's endorsement of the Employment Pass / Work Permit.
- → If Employment Pass / Work Permit has not yet been approved
- Copies of the Employment Pass application (Form 8)
- Copy of company's letter to Singapore Immigration Department for this application
- Copy of the acknowledgment receipt from Immigration Department for this application

## For Returning Singapore Citizen

- Declaration of Facts
- Passport copies showing personal particular
- Company's letter to Singapore Customs giving details such as, dates of return, reasons for return, etc. (a sample copy is available at our office)
- Copies of passport pages showing the Immigration Department's (foreign country) endorsement of his arrival and departure dates. (This is to prove that owner has resided in a foreign country for not less than 6 months)

### For Foreigners Acquiring Permanent Residence Status

- Declaration of Facts
- Passport copies showing personal particulars
- Copy of passport page showing Singapore Immigration's endorsement of <a href="Entry Permit">Entry Permit</a>
- Copy of the <u>Approval for Permanent Residence</u> letter or <u>In-Principle Approval for Permanent Residence</u> letter from Singapore Immigration.

On top of these, if owner has video tapes / disc and alcohol in consignment, he has to complete these two forms:

- Video statement for exemption from censorship (please refer to explanation notes on importation of videos)
- Wine List (for Customs to access Duty & GST amount)

Please note that alcohol, tobacco products, motor vehicles etc are not eligible for any Duty & GST exemption.

If owner does not have any of these documents ready when shipment has arrived, he could choose to EITHER

- Customs clear shipment by paying 3% GST, or
- Hold shipment at Port until documents are ready (Port store rent / Demurrage charges will incur and will be invoiced either to Origin Agent or owner)

**NOTE:** Surface shipments will incur Port store rent & Demurrage charges if they remained at the Port after 3<sup>rd</sup> day of its arrival.

Air shipments will incur Port store rent & Removal charges if they remained at airport after 48 hours of its arrival.

- 2. Video statement for exemption from censorship
- 3. Wine list

Please request owner to complete the above documents at origin and fax to us before shipment arrives. As for other documents that need to be obtained from account (i.e. Employment Pass application, Company's letter etc), please provide contact at account in Singapore. We will liaise with them from here.
